### **CYBERSECURITY MALAYSIA ENHANCES ITS DIGITAL FORENSIC CAPABILITIES THROUGH PARTNERSHIP WITH NATIONAL FORENSIC SERVICE, KOREA**

**SEOUL (10 December 2014)** – The Ministry of Science, Technology and Innovation (MOSTI) via its agency, CyberSecurity Malaysia, and National Forensic Service (NFS), Korea today have agreed to enter the Memorandum of Understanding (MoU) to establish working relationship, witnessed by YB. Datuk Dr Ewon Ebin, Minister of Science, Technology and Innovation (MOSTI), Malaysia in conjunction with the Prime Minister, YAB Dato' Sri Mohd Najib Tun Abdul Razak official working visit to the Republic of Korea (R.O.K) from 9 - 11 December 2014. MOSTI was represented by Dr. Amirudin Abdul Wahab, Chief Executive Officer (CEO) of CyberSecurity Malaysia, while National Forensic Service (NFS) Korea was represented by Joong Seok Seo, its Director General.

“The collaborations formed by CyberSecurity Malaysia with NFS is expected to yield higher level of expertise of personnel serving the Malaysia’s cyber security agency, technology transfer activities both in the short and long term, improving Malaysia’s cyber security resilience through development of new approaches and method and stronger industry linkages between the Korean and Malaysian companies in the field of cyber security field” said YB. Datuk Dr Ewon Ebin, the Minister of Science, Technology and Innovation (MOSTI), Malaysia who was also present to witness the MoU exchange.

CyberSecurity Malaysia is the national cyber security specialist agency under the Ministry of Science, Technology and Innovation (MOSTI) Malaysia, and as a technical agency mandated by the Government to monitor e-sovereignty of the country. In ensuring its capabilities and knowledge are always at par with the current
